## Membership, Trials, and Billing

**1. Subscription Basis:** Animal Training Academy (ATA) is a subscription-based service. By signing up for a membership (including trial memberships), you authorize ATA to charge your provided payment method a recurring fee at the frequency and price specified at the time of purchase.

**2. Trial Memberships:** If you register for a trial membership (e.g., a \$1 for 30 days trial), your membership will automatically transition into a full-priced monthly membership at the end of the trial period unless you cancel before the trial expires. It is the member's responsibility to track the trial expiry date.

**3. Payment for Access:** Membership fees are paid for access to the ATA platform, community, and resources, regardless of whether you choose to use those resources during the billing period.

**4. Automatic Renewals:** To ensure uninterrupted service, memberships renew automatically. In the event of a card expiry, many banking networks provide updated card details to our payment processor (Stripe) to prevent service interruption.

**5. Cancellation:** You may cancel your membership at any time through your Account Dashboard. To avoid the next scheduled charge, you must cancel before your renewal date/time. Cancellations are effective immediately for future billing; however, no partial refunds are provided for the remaining time in the current billing cycle.
